**The recommended honorarium for pulpit supply for 2010 will be as follows:**

- 1. Ministers of the Word and Sacrament: \$100 plus mileage reimbursed at the standard IRS rate (2010 IRS rate is: .50 per mile effective 01-01-10)**
- 2. Commissioned Lay Pastors: \$75 plus mileage reimbursed at the standard IRS rate.**

**Commissioned Lay Pastors (CLP) With An On-Going Relationship With A Particular Church:**

Commissioned Lay Pastors (CLP) who have an on-going relationship with a particular church are considered as ministers for income-tax and social security purposes, and may have a portion of their earnings designated as tax-free housing allowance. These CLPs should have their taxable income reported on a W-2 with no employer withholding. They are to be considered as self-employed, and each CLP is responsible for their income-tax liability and their full social security tax (15.3%). (See *IRS Publication 517* for more information.)

**CLPs That Supply Preach:** CLPs that supply preach at a church with no on-going covenant relationship and who receive more than \$600 from that particular church should have their income reported on a 1099 with no employer withholding.
